

Drummond, formerly a freight conductor on the Evansville and Terre Haute Railroad, sued the company for damages, alleging that he had been blacklisted by Superintendent Corbett, which made it impossible to secure employment on any railroad since the Debs strike in 1894, at which time Drummond lost his job, it is alleged. On account of the part he took in the American Railway Union. The jury awarded him 3,500 damages against the railroad. There is said to be but one other case on record where the plaintiff was awarded damages for being blacklisted. Case was in Florida, last January. cSee in this connection the opinion of the majority in Pleas of Lucas Co. , by Pratt, J. , in Mattison v. L. S. and M. S. R. R. Co. , 21151. Prior Rep. 276. party attempted to use it, and a conductor of the railroad company took it up and collected fare. Morton brought the suit to recover for the value of the book. He won in the Justice Court, but lost in the Common...
